***Please do not send the instructions with the application***

IHDA reserves the right to refuse, correct or cancel for cause this application. Any misrepresentation on this application is one example of “for cause” cancellation.

Any application for which all information and supporting documentation has not been supplied in a timely manner will be considered to be “incomplete” and may be returned to the owner.

**To be eligible, one of the following must be true and the appropriate document must accompany this application:**

- 1) The dog is currently registered or has a puppy paper that has been issued by one of the below approved registries as a Standard, Miniature or Toy Australian Shepherd.
- 2) The dog has an NAMASCUSA Individual Dog Registration Application and was whelped prior to January 1, 2014.

**If your dog is dual registered as a Miniature American Shepherd:**

As the owner, you will need to determine if your dog is going to be registered with IHDA as a Miniature American Shepherd or an Australian Shepherd/variety. You will need to submit the appropriate registration certificate and application to designate what breed you are choosing.

**Please make your choice wisely before submitting paperwork to IHDA as once you designate the breed, IHDA will not change the breed designation. Litters will be registered as the breed the dam is registered as.**

- If the applicant dog is currently registered, you must provide a copy of the applicant dogs' current registration certificate(s) which lists the current owner(s). The registered name of the dog requested on this application may not differ from that on the existing registration certificate.
- If the applicant dog has a puppy paper you must fully complete that form, with all required signatures, and attach to this application. The requested name is limited to 36 characters (including spaces).
- If the applicant dog was whelped prior to January 1, 2014 and you have a NAMASCUSA Individual Dog Registration Application, you must fully complete that form, with all required signatures, and attach to this application. The requested name is limited to 36 characters (including spaces).
- For all applicant dogs, except those dogs having NAMASCUSA/SDRS issued puppy papers, provide a 3 generation pedigree showing the parents, grandparents, and great-grandparents, complete with all registered names and registration numbers, or as much of a 3 generation pedigree as is known, if possible. Both parents of the applicant dog must have registration with a recognized registry as listed above. Copies of registration certificates and/or certified pedigrees from one of the registries listed above may be required for verification of dogs within the 3 generation pedigree if IHDA does not currently have this information available. Without proper verification of 3 generations the applicant dog will not be considered 3 generation verified.
- Kennel names will be used exactly as how they are registered with IHDA.
- No punctuation will be used in the first word of the dogs name regardless if the dog is currently registered.

### **Pedigree Verification Process**

Verification of generations is done using copies of registration certificates and/or certified pedigrees issued by acceptable registries as listed above. In some instances, IHDA may already have these documents and therefore some of the dogs in a pedigree may already be verified. However, in many instances IHDA does not have any information on dogs within a pedigree especially if the dog is registered with another registry. IHDA does not have access to other registries' databases. Therefore, the only way verification can occur is to have an official document, as described above, to verify not only a dog's registered name and registration number but to also verify that dog's connection (parent, grandparent, or great-grandparent) to the dog. You will not be able to order a Certified Pedigree if we do not have 3 generations of verified dogs in our system.

## **Fee's**

- \$ 25.00 For single dog registration
- \$20.00 Per dog if 5 or more dogs are submitted and paid for at the same time.
